Community Awareness & Education - Jacob's Heart plays a critical role in raising awareness within its communities through its materials, media relations, and special events. By forming partnerships with schools, groups and organizations, Jacob's heart also provides information about the impact of pediatric cancer upon children and families. The Program involves social, education and recreational events as well as Art from the Heart, an expressive community arts program and the delivery of unique handmade kids cards and special celebrations.

4b (Code:) (Expenses \$ 151,851. including grants of \$) (Revenue \$)

The Practical and Financial Assistance Program relieves outside stressors faced by families enduring pediatric cancer. Program Components: a) direct payment of bills such as rent, phone, utilities, fuel and groceries; b) financial assistance for funeral or other expenses when a child dies; c) resources and referrals; d) caregiver support provided by trained volunteers; e) biweekly home deliveries of nutritious groceries, recipes and cooking instructions; and f) transportation to medical treatment, pre-paid gas cards.

4c (Code:) (Expenses \$ 128,277. including grants of \$) (Revenue \$)

The Emotional Support and Counseling Program alleviates the isolation, fear and depression associated with childhood illness and death. Program components: a) bilingual family and individual counseling; b) support groups for parents, teens and children in treatment and bereaved; c) art and sand tray therapy in the home, hospital or group setting d) Camp Heart + Hands: a life-changing weekend camp where families of children with cancer can forget about their disease and create bonds with other families enduring pediatric cancer. Camp is staffed by pediatric ICU nurses and oncologists from Lucile Packard Children's Hospital at Stanford; e) peer mentorship: a dynamic family support network made up of veteran and new families with family activities social events and celebrations honoring important milestones.
