Emotional Support and Counseling: Family Support Specialists and the staff psychologist facilitate bilingual, one-on-one emotional support and/or clinical counseling with the child, their parents, and siblings; conduct support groups for parents, teens and children; and provide expressive art sessions (e.g. art, music, sand tray therapy, journaling) to families of children in treatment for cancer and those who are bereaved. Services included: 260 group and individual counseling sessions; 30 peer mentoring outings for teens with cancer and their siblings; 117 campers attended Camp Heart + Hands; 35 bereaved family members attended our first annual Forever Loved Retreat.

Practical and Financial Support: In 2017 Jacob's Heart provided the following services to 325 children with cancer or other life-threatening illnesses and 1,467 of their family members: \$282,118 in direct financial and practical support, including payment for rent, utilities, gas, groceries, meals, funeral assistance and other necessities; 4,406 bags of nutritious groceries delivered to homes and hospital rooms; 381 rides to treatment; 4,745 hours of support and guidance, including 988 home and hospital visits.

Community Education: Twenty years ago Jacob's Heart led the efforts to declare September Childhood Cancer Awareness Month by executive order in the State of California, which has since grown to national significance. Through community education and awareness, we strive to inspire compassionate action within local communities, to create a safety net of support for the unique needs of each child and family through professional education and training in the art and practice of pediatric palliative care; events in honor Childhood Cancer Awareness Month; proclamations with state and local governments; and community memorial ceremonies to ensure that no child is ever forgotten.

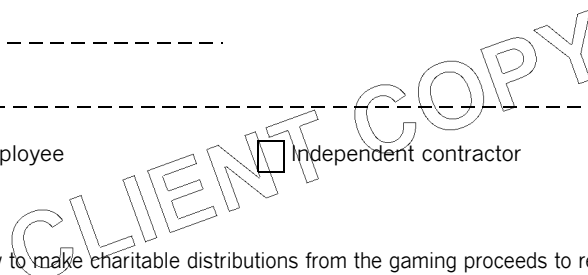
